- Includes 1,446 unvested RSUs, 804 performance shares earned but not vested with respect to performance shares granted on 1/12/2009 and DERs related thereto.
- DERs accrued on the performance shares granted on 6/2/08 under the 2006 Equity Incentive Plan. Each DER is the economic equivalent of one share of ABM common stock. DERS vest in the same manner as the performance shares to which they relate.
